主旨:有關「台帛安全旅行圈」機制暫停期間我國人入境帛琉之檢疫規定事,敬請查 昭。

說明:

- 1. 依據外交部 111 年 3 月 30 日外亞太一字第 1111301021 號函辦理。
- 2. 查「台帛安全旅行圈」於上(110)年8月11日重啟,旅客自我國赴帛之檢疫措施為,國人須「1個月內無出入境史(不含帛琉)」,並於出國當日5小時前至機場進行PCR採檢並取得核酸檢驗陰性報告,入帛後無需檢疫即可在帛旅遊。
 - 3. 惟嗣因帛琉疫情急速升溫,經中央流行疫情指揮中心評估,為維護台帛雙方防疫安全,指揮中心業於本(111)年1月25日宣布將帛琉之國際旅遊疫情建議等級提升至「第三級警告」(Warning),並暫停台帛安全旅行圈機制,然目前出境赴帛之檢疫措施卻仍維持原台帛安全旅行圈規定,已與現况不符。考量現為台帛安全旅行圈暫停之過渡階段,我宜回歸尊重帛國之國境管轄主權,爰我國人入境帛國措施擬參照帛國現行規定予以調整。
 - 4. 依據帛琉衛生暨公共服務部本年1月16日第07-22號行政命令,我國人 赴帛適用第1條(Section 1)第B項,相關規定如次:
 - (1)PCR檢測規定:赴帛國人應出具起飛前3日內之PCR陰性檢測報告,或起 飛前1日內之Antigen抗原快篩陰性檢測報告。
 - (2)國人赴帛之旅遊史身分限制:
 - I.14天內無出入境史;
 - Ⅱ. 無COVID-19感染史;
 - Ⅲ. 過去2個月內未曾密切接觸疑似/確診病例,且未有自我隔離、居家 檢疫及自主健康管理史。
 - (3)於帛之檢測:預計停留超過4日之旅客(抵達首日為第0日),入境後第4 日須進行檢測。
 - 5. 為尊重帛國主權並便利我國旅客,請會員旅行業者,以廣為周知並配合自 4月6日起實施。

DIRECTIVE NO. 07-22

AUTHORIZING ISOLATION, QUARANTINE, AND RESTRICTED ENTRY MEASURES TO PREVENT AND MITIGATE CORONAVIRUS DISEASE 2019 (COVID-19)

WHEREAS, Coronavirus Disease 2019 (COVID-19) is a severe acute respiratory illness that was first identified in December 2019, and that occurs through human-to-human respiratory transmission; and

WHEREAS, COVID-19 presents a major threat to public health in the Republic, and is particularly dangerous for those who are immunocompromised or have underlying medical conditions; and

WHEREAS, the World Health Organization (WHO) declared the COVID-19 outbreak as a Public Health Emergency of International Concern (PHEIC) on February 11, 2020, and further characterized it as a Pandemic on March 12, 2020. The WHO and the US Centers for Disease Control and Prevention (CDC) recommend that all countries and territories implement aggressive measures to prevent and control the transmission of COVID-19; and

WHEREAS, as of January 16, 2022, over 96% of Palau's population has been vaccinated against COVID-19; and

WHEREAS, the Ministry of Health and Human Services (MHHS) has established COVID-19 protocols for case prevention, identification, and management, and numerous businesses are now certified through the Pandemic Safety Certification Program for establishing COVID-safe practices such as mask wearing, social distancing, regular disinfecting, and hand hygiene; and

WHEREAS, the Republic coordinates closely with the WHO, CDC, and Pacific Islands Health Officers Association (PIHOA) on public health guidance, best practices and suggested guidelines for mitigation of COVID-19;

NOW THEREFORE, by virtue of the authority vested in me as the Director of Public Health of the Ministry of Health and Human Services, I hereby authorize revised requirements for International Entry and as required for Isolation and Quarantine pursuant to 34 PNC § 102(m) and 34 PNC § 701 and the MHHS Rules & Regulations for Isolation and Quarantine of Contagious Diseases to mitigate the spread of COVID-19 in the Republic of Palau, as follows:

Section 1. Vaccine and Testing Requirements Applicable to International Travel into the Republic:

 <u>COVID Safe Practices</u>. All Travelers are advised to practice social distancing, wear a mask over the nose and mouth when within six feet of others, and avoid large indoor gatherings for fourteen (14) days prior to their travel to the Republic.

- <u>Unvaccinated Individuals Under 12 years of age</u>. Unvaccinated individuals under 12 years of age are permitted to travel to the Republic and must adhere to all other requirements of this section.
- <u>Children Under 3 years of age</u>. Children Under 3 years of age are exempt from the requirement to be COVID-19 tested prior to travel into the Republic.

A. Transit and Entry Protocols:

- Steps for Entry:
 - 1. Vaccination. Travelers must submit proof of complete COVID-19 vaccination with final dose administered at least fourteen (14) days prior to departure to the Republic. Vaccine received must be authorized for emergency use or approved by either the US Food and Drug Administration (FDA) or the World Health Organization (WHO), or the Medigen vaccine authorized by the Republic of China Taiwan's health authorities.
 - *For commercial air travel, travelers must submit proof to the airline.
 - 2. Negative COVID-19 PCR Test or Documentation of Recovery. All Travelers must also provide proof of either:
 - a. A negative result of a COVID-19 PCR test (any type of PCR test, including NAAT, RT-PCR, qPCR, RT-LAMP, TMA, molecular test, isothermal amplification, ddPCR, or CRISPR), and such test must be taken within three (3) days prior to departure from the point of origin to the Republic; or
 - b. A negative result of a COVID-19 antigen test (WHO or US FDA authorized or approved test), and such test must be taken within one (1) day prior to departure from the point of origin to the Republic; or
 - c. Documentation of recovery from COVID-19 which includes proof of a recent positive viral test and a letter from a healthcare provider or a public health official stating that traveler has recovered from COVID-19 and is cleared to travel.
 - *For commercial air travel, travelers must submit proof to the airline.
 - 3. Testing and Mitigation Orders After Arrival. All Travelers shall be COVID tested following their arrival to the Republic as deemed appropriate by MHHS and are required to follow all requirements stated in the Mitigation Orders issued upon arrival.
- B. Travel Entry for Residents from Authorized Jurisdictions Under Special Conditions:
- Authorized Jurisdictions are those that have been approved by the President of the Republic to establish travel to the Republic of Palau under special conditions. Residents of Authorized Jurisdictions may be exempted from Section (1)(A) above and travel to Palau upon the following conditions:
 - 1. Submit a negative result of a COVID-19 PCR test (any type of PCR test, including NAAT, RT-PCR, qPCR, RT-LAMP, TMA, molecular test, isothermal amplification, ddPCR, or CRISPR) taken within three (3) days prior to departure or a negative result of a COVID-19 antigen test (WHO or US FDA authorized or approved test) taken within one (1) day prior to departure to the Republic; and
 - 2. No travel history to destinations outside of the Authorized Jurisdiction within the last 14 days prior to departure from the Authorized Jurisdiction; and
 - 3. No prior history of COVID-19 infection, no close contact with any person who is under investigation for COVID-19, no close contact with laboratory-confirmed COVID-19 case,

and no person under a self-isolation, home quarantine, or self-monitoring order for the last two months; and

4. <u>Testing After Arrival</u>. All Travelers shall be COVID tested on the fourth (4th) day following their arrival to the Republic.

C. Guidelines for Vessel Crew:

- The crew of any aircraft or vessel entering the Republic must provide negative COVID-19 PCR test results test (any type of PCR test, including NAAT, RT-PCR, qPCR, RT-LAMP, TMA, molecular test, isothermal amplification, ddPCR, or CRISPR) and proof of full vaccination; or provide official documentation on infection control measures implemented for aircraft or vessel operations and health management protocols for personnel;
- Any crew member of any air or water vessel that disembarks into the Republic of Palau shall be subject to these regulations, except in cases wherein an air or water vessel breaks down unexpectedly within the territory of the Republic. In such cases, any crew member disembarking such vessel does not fulfill specified entry requirements, they shall then undergo other mitigation measures as deemed necessary by MHHS.

Section 2. Isolation. The isolation of persons infected by COVID-19 is hereby authorized as follows:

- Any person proven or strongly suspected to be infected with COVID-19 shall be isolated for a
 period as deemed necessary by MHHS at either at an isolation facility or at home at the discretion
 of the Director of Public Health; and
- Infection may be proven or strongly suspected based on a presumptive test result, and/or a
 confirmatory test result by means of authorized assays for viral testing include those that detect
 SARS-CoV-2 nucleic acid or antigen.
- Isolation Facilities: The Alternate Care Site (ACS) at Kalau Gym in Meyuns, Koror shall be the primary Isolation and care Facility for non-critical infected persons. The isolation rooms of Belau National Hospital shall be reserved for infected persons in need of critical care. MHHS shall identify other appropriate and adequate facilities, either public or private property to be designated as Isolation Facilities for COVID-19 infected persons as necessary.

Section 3. Quarantine. The quarantine of persons exposed to COVID-19 is hereby authorized as follows:

- Any person determined to have been exposed to COVID-19 shall undergo mandatory quarantine for a period up to fourteen (14) days, unless otherwise specified below; and
- Any person who has had direct contact with a person infected by COVID-19 shall be considered to have been exposed to COVID-19 and quarantined for a period up to fourteen (14) days; and
- Any person who has had indirect contact with COVID-19, such as contact with potentially
 contaminated surfaces, may be considered to have been exposed to COVID-19 and quarantined for
 an appropriate period; and
- Any person who has had indirect contact with a person who has been exposed to COVID-19 may be considered to have been exposed to COVID-19 and quarantined for an appropriate period.
- MHHS shall identify appropriate and adequate facilities, either public or private property, to be designated as Quarantine Facilities for exposed and potentially exposed persons.
- If any quarantined person is found to be infected, that person shall be promptly relocated to an appropriate isolation facility, which may include the individual's home if determined appropriate by the Director of Public Health.

Section 4. Applicability to all Travel into the Republic.

 This Directive is intended for all travelers entering the Republic, including those entering the Republic via commercial or private vessel. Private and charter vessel travelers must submit proof of vaccination at least 96 hours before departure and test results within 24 hours of departure to MHHS for verification.

Section 5. Delegation of Authority.

 Pursuant to 34 PNC § 101 and Section 4.10 of the MHHS Rules & Regulations for Isolation and Quarantine of Contagious Diseases, Authority to order the isolation or quarantine of persons found to be infected or exposed within the Republic of Palau or upon arrival into the Republic either by sea or at the Palau International Airport, is hereby delegated to the Director of the Bureau of Public Health.

Section 6. Exemptions.

• No exemptions to the isolation or quarantine requirements of this directive may be made, except by the Director of Public Health and in writing. The Director may issue exemptions on an individual, case-by-case basis, based only on an articulable medical justification. The Director may also authorize transit for unvaccinated individuals and those that have received an unauthorized vaccine.

Section 7. Term.

 This directive supersedes and replaces MHHS Directive No. 39-21, which took effect on December 16, 2021. Unless cancelled, revoked, or re-issued, shall remain in effect for 90 days from effective date.
